

# Accessibility Plan for Shoreham Beach Primary School 2022-2025



## Aims

Shoreham Beach Primary School is committed to having a fully accessible environment which values and includes all pupils/students, staff, parents and visitors, regardless of their backgrounds and needs.

Specifically, the school's accessibility plan is aimed at:

- Improving the physical environment of the school to enable disabled pupils/students to take better advantage of education, benefits, facilities and services provided;
- Increasing the extent to which disabled pupils/students can participate in the curriculum;
- Improving the availability of accessible information to disabled pupils/students and their parents/carers.

This accessibility plan has been informed by:

- An audit of the accessibility of the school buildings.
- A review of staff awareness and understanding of disability discrimination, access issues and the promotion of disability equality.
- The access needs of disabled children, staff and parents/carers.

As a consequence of these activities, the following targets and actions have been identified

## 1. Improving access to the physical environment

To ensure that all pupils and visitors to Shoreham Beach School are able to access all areas of the building.	Gather information as needed with regard to the needs of pupils and families. Ensure that ramps are appropriate for wheelchair users.	Ongoing	SENCo  Premises Manager	The whole school site is accessible.
To ensure that fire escapes are always easily accessible.	Check fire doors regularly to ensure good working order. Ensure Fire Exit signs are standardised. Regularly review access to Fire Escapes.	At least annually	Premises Manager	Fire procedures are clear and exits easily accessible.
To ensure that paving and astroturf is safe for wheelchairs, walking frames and walking sticks.	Regularly check and replace paving slabs/astroturf. Ensure paths are free of debris.	Ongoing	Premises Manager	Entrances and exits are easily accessible for all.
To ensure corridors give enough space for wheelchairs to access	Keep cloakrooms tidy.	Ongoing	Premises Manager	Corridors will be clear of personal belongings allowing safer entrances and exits.

To ensure the teaching and learning needs of all pupils are met through effective differentiation.	Focus on differentiation as part of lesson "drop ins" and pupil progress meetings. Identify effective use of differentiation in classroom practice and books.	Ongoing	SLT	All pupils have equal opportunities to achieve their potential. Monitoring shows effective differentiation.
To ensure learning resources fully meet the needs of all pupils.	Gather information regarding the needs of pupils. Provide specialist equipment as necessary Identify new software to support pupils' access to the curriculum.	Ongoing	SLT	Progress of pupils with additional needs is in line with that of other pupils.

To ensure all members of the school community can access information.	Information available in different languages as necessary. Ensure classrooms are dyslexia/communication friendly.
